2017/2018

It is with mixed feelings that I start my final year as Board President for Paws for Hope Animal Foundation, a position I have now served for four years. These past years have been memorable and challenging. We have worked hard to build community and organizational partnerships, expand our veterinary outreach beyond Vancouver, bring about meaningful change to better the lives of animals and their people, and formalize the board and its governance. I feel confident we as an organization are on the right track with our Executive Director leading the way and with a committed and talented group of individuals on our board.

This past year has seen the banning of the sale of dogs, cats and rabbits in pet stores spread further across the province of British Columbia and elsewhere. From Delta and Surrey, to Vancouver and Victoria, municipalities are taking heed.

Our veterinary outreach has brought us to new communities in the lower mainland. We held clinics in New Westminster and Surrey, and are in the process of planning our first clinic in Langley. We continue to partner with Community Veterinary Outreach and Direction's Youth Services to provide a one health oriented clinic to street-involved youth and their pets in the fall each year, and have expanded our network of partner veterinary clinics to provide discounted or no-cost spay and neuters to low-income families across the province.



The second annual Connection and Collaboration conference will be held in October. I am excited to be able to attend this year and am looking forward to the keynote by Lori Weise, the founder of Downtown Dog Rescue. Our inaugural conference was a huge success and this year's will be filled with informative and inspiring talks and discussions with attendees representing the animal welfare and rescue community from across the province and beyond.

This next year will be spent working closely with our incoming President who will be taking over after the 2019 Annual General Meeting. I am looking forward to working with her and on refocusing my efforts on veterinary outreach for the homeless and low-income. There is still so much work to be done and Paws for Hope will continue to play an important role in the advancement of animal welfare issues and in the development of support systems for the rescue community and for vulnerable populations and their pets.

A very special thank you to our donors and supporters. Without your involvement and commitment to Paws for Hope we would not have reached the heights we have, and will not continue to grow to the organization we envision. We are an organization with ambitious plans and exciting hopes for the future.

The suffering that is caused when animals are bred for profit is something that keeps me up at night. This past year we saw many victories that put us one step closer to ending this suffering.

When we got word that a pet store in Burnaby, that was notorious for selling puppies from puppy mills across the US, closed down due to public pressure and was moving to Vancouver we instantly took action. We set up a coordinated letter campaign, demonstrated outside of their new location and persisted until we were able to meet with Vancouver City Councillor, Andrea Reimer. Our goal was for Vancouver to implement a bylaw that would ban the retail sale of cats, dogs and rabbits—and we were successful!

Our Pets Are Not Products campaign is not new. We have been advocating on behalf of animals bred for profit since 2012 and each year, we launch an awareness campaign, usually around Christmas time, reminding people that pets do not make good gifts. Until this year, however, we had only successfully lobbied the City of New Westminster to implement a ban. Our victory in Vancouver was a major game-changer and was the beginning of a movement across B.C. for cities to follow Vancouver's lead and implement similar bans. Since Vancouver, bans have been implemented in Surrey, Delta, Victoria and yes, finally Burnaby.

The significance of what we have accomplished is not lost on me, and serves as an important reminder of what can happen when people come together to fight injustice and suffering. It serves as proof that we have the power to change law and policies that cause harm. It is testimony that together we can improve the lives of animals and it signals a call to action.

Animals play a significant role in our lives. We understand their sentient nature more than ever and their companionship enriches our lives in ways that are sometimes difficult to articulate. It is our duty to be their voice. It is our duty to fight against cruelty. It is our duty to put an end to inhumane business practices. And it is our duty not to give up. If not us, then who?

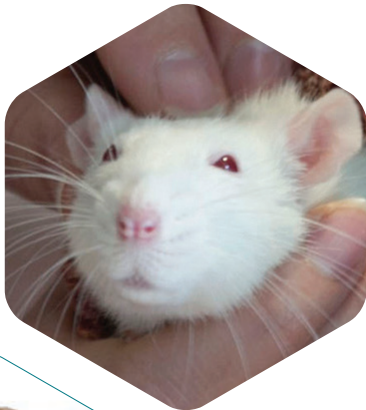

Animal Welfare Advisory Network of BC

The Animal Welfare Advisory Network of British Columbia (AWANBC) enables organizations to work together to support strategies around specific projects and initiatives associated with companion animal welfare. The network is comprised of a volunteer membership and steering committee.

PROJECTS

COMMUNITY MAPPING OF REMOTE AND UNDERSERVED COMMUNITIES

Many small and remote communities are challenged with dealing with animal welfare issues because of lack of access to veterinary hospitals, animal control and shelter services. The goal of the mapping project is to get a more accurate picture of the challenges communities face to help inform future projects that will serve to support and enhance animal welfare services in remote communities.

RESCUE STANDARDS OF PRACTICE

The call for rescue standards of practice for community-based animal rescue organizations follows rising concern about the increased number of animal rescues, the mass importing of dogs from the US and other countries, and the spread of disease. The goal of the rescue standards project will be to create standards of practice that are informed by science and acknowledged best practices with an accreditation process to confirm organizational compliance.
